The Nordic Delayed Information contains the same Information included in Nordic Equities Level 2, Nordic Derivatives Level 2 and Nordic Fixed Income Level 2 except from the Information exempted in the detailed product description, e.g. Index Population, Debtor Composition, Cashflow Open Series, Extra Redemptions, Notification Drawing, Notification Drawing Percent and Free Float.

Delayed information means information in respect of which more than fifteen minutes have elapsed from the time the Information was first transmitted to the market by the Information Provider.

Nordic Delayed Subscriber

Nordic Delayed Subscriber gives the Subscriber right to unlimited redistribution of Information. 15. VINX Indices
